Interim Lead Pastor report

Bethel had lots of changes, interim process in August 2009, then again in November 2012. Members feel that we already did this and do not want to do this again. 5 tasks Carol wants to pay attention to: Heritage, Identity, New Leadership, Denomination Connections, New Future.

4 spiritual questions: What has formed us? Who are we now? Who is God calling us to be? How are we going to get there? You are calling a lead pastor to join your vision, but the vision needs to be clear. What are our core values?

Our numbers have changed, mainly during the economically difficult times. But we are also about \$40K behind in expected giving. Do we need a new plan?

Carol's proposal: Back to Basics:

- **A Active Listening** (Seminar Feb 9 and March 9) Meet, listen and learn identify core values and stories, what motivates and energizes.
- **B Building up Community** (prayer and vision (40 Days of Prayer Triads begins Ash Wednesday; dream together (leadership retreat, April 27)
- C Committing to Your Future (Stewardship of time and talents (Spring), invite new lead pastor to join you)

Associate Pastor report

Gabi reviewed the different areas that were emphasized in her letter of call. She highlighted two areas:

Cultural diversity has an internal and external component. Worship: Missa del Mundo, Fun with Faith classes on Judaism, Indian Christians, and Palestinian Christians.

Constitution changes

Mary Thomas

There are many mandatory from the ELCA.

- Designated by '*' within framework
- Some are additions
- Some are clarifying
- Some are substantive (e.g., process to terminate relationship with ELCA)

A few changes were developed by Council to enhance relevance of constitution to Bethel

- Changes may be found in Constitution found on Bethel website
 - Mandatory are red, Bethel-specific are green
- Specific issues germane to Bethel highlighted in following slides
 - Call process (ELCA change)
 - Member meeting notification
 - School Board By-laws

• *6.03: Church Affiliation

- Clarification change
- This congregation agrees to call pastoral leadership from the clergy roster of the Evangelical Lutheran Church in America in accordance with its call procedures except in special circumstances and with the approval of the bishop of the synod. These special circumstances are limited either to calling a candidate approved for the roster of ordained ministers of the Evangelical Lutheran Church in America or to contracting for pastoral services with an ordained minister of a church body with which the Evangelical Lutheran Church in America officially has established a relationship of full communion.

• *C9.07 The Pastoral Office

• During the period of service, an interim pastor shall have the rights and duties in the congregation of a regularly called pastor and may delegate the same in part to a supply pastor with the consent of the bishop of the synod and this congregation or Congregation

Council. The interim pastor and any ordained pastor providing assistance shall refrain from exerting influence in the selection of a pastor. Unless previously agreed upon by the Synod Council, an interim pastor is not available for a regular call to the congregation served.

• C10.03 Congregation Meeting (change developed by the council)

• Notice of all meetings of this congregation shall be given at the services of worship on the preceding two consecutive Sundays and by mail to all members at least 10 days in advance of the date of the meeting.

The posting of such notice in the regular mail, with the regular postage affixed or paid, sent to the last known address of such members shall be sufficient.

Electronic notice of meetings may be provided rather than notice by regular mail provided that all members are informed in a timely manner.

School Board Bylaw Changes

- The Bethel School Board is a standing committee of Bethel Lutheran Church. The Bethel School Board shall oversee the management of the school to ensure its actions are in congruence consistent with the philosophy and mission of Bethel Lutheran Church.
- School Board Membership
- Appointed members may complete their term if there is a change of status during that term, in that they are no longer a member of Bethel Lutheran Church or not the parent of a student enrolled at Bethel Lutheran School.
- Terms
- The Chairperson elected at the annual meeting shall serve a term of three two years. The first set of regular board members appointed subsequent to the adoption of these bylaws shall serve for staggered terms of up to three two years. Subsequently, members as needed shall be appointed each year for terms of three two years.
- Members shall not be eligible to serve more than two three successive full terms.
- Responsibilities
- Encourage school families to participate in a faith community.

There was a motion approve the changes that need to be ratified at our summer meeting. Donna made a motion to approve, there was a second. Motion passed.
